

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.wayineers.com and Wayineers LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Wayineers LLC include www.wayineers.com and Wayineers. The Wayineers website is a Coaching and Consulting site. By using the Wayineers website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Wayineers may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Wayineers's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Wayineers's public message boards, this information may be collected and used by others.
